Vendor Information & Agreement

Vendor Agreement

1. All vendors must be at least 21 years of age to purchase a vendor table.
2. All vendors must purchase a Full Conference pass in order to purchase a vendor table.
3. All vendors agree to the Attendee Registration Agreement in addition to this Agreement.
4. All tables are sold as 4 feet long and include a floor-length table cloth or skirting and two chairs. Table widths are 36 inches. If only one table is purchased, you will be grouped with another vendor.
5. Tables may be located inside the meeting room or outside in the Atrium. You may request either location subject to availability.
6. Vendor merchandise may not extend beyond the table's boundaries without approval from the Conference Organizers. Please inform the Organizers if you believe you need room in front of your table.
7. All areas have electricity available. Please bring a power strip and extension cord to ensure a connection.
8. Wireless Internet is available at no charge in all areas of the hotel and meeting rooms.
9. Vendor tables must be attended at all times during tradeshow hours. ParaNexus staff is not authorized to watch vendor tables at any time for any reason.
10. Vendors with tables in the Atrium can store merchandise in the main conference room overnight.
11. No other items or services are included unless listed in this Vendor Agreement. The Conference Organizers are not responsible for payment of any non-listed items or services by the hotel.
12. Speakers will be provided table space at no charge. Speakers may be grouped two to a table.
13. Vendors must fill out a table request form specifying the type of products they wish to sell and other relevant information. Once the vendor application has been approved (usually within 48 hours or less), the vendor will be invoiced via PayPal for the total amount of the requested table, which is due upon receipt. Your requested table will not be locked in and final until payment is received. All invoices not paid within 3 business days will result in the requested table being released to other vendors.
14. Vendors are NOT required to pay a percentage of sales to the ParaNexus Conference.
15. The Conference Organizers reserve the right to change the requested table to another table in the case of two simultaneously submitted requests for the same table. Table requests are honored on a first received, first served basis. The Organizers will notify you by email if your table has been purchased by another party, in which case you may choose from any remaining tables (if available).

16. By registering for a vendor table, you understand that you are fully responsible for any and all products you offer on your table during the event including any applicable taxes. Furthermore, you hereby agree to release and hold harmless Doug Kelley, Jari Mikkola and their families, Kelley Training Systems, Inc., CSI-America, LLC, (ParaNexus Organizers), ParaNexus staff, assistants and volunteers, the SPIRITeam and In the Shadows - Paranormal Project (Organizer's research groups) including all team members, fellow conference attendees, the hotel, its owners, staff, and vendors, Conference speakers and vendors, property owners or staff of the investigation locations, or any other person or business directly or indirectly connected or associated with the ParaNexus Conference from liability or loss to persons or property, infringement of any right, expenses of any kind, or any other claim or cause of any kind in perpetuity. Furthermore, the people, businesses, and entities named in this paragraph are not responsible for accidents, property damage, damage of any other kind, or theft before, during, or after the event.
17. The ParaNexus Conference Organizers including any and all staff or agents do not endorse any vendor's merchandise, exhibits, views, beliefs, or actions. All vendors are deemed to be separate business entities and responsible for sales tax collection (7%), or any other applicable taxes or Worker's Comp. You agree to hold the ParaNexus Conference Organizers including any and all staff or agents harmless against any and all merchandise bought, sold, or brought onto the premises of the conference.
18. Pornographic, sexually explicit, graphic, racially offensive, or any other kind of offensive merchandise, products, or materials are not allowed to be sold at this Conference. Please contact the Conference Organizers to review and/or approve any item(s) that you believe might be offensive.
19. ParaNexus Organizers reserve the right to refuse admission or continued participation to any vendor, including removal of any vendor from the Conference location, for any of the reasons below, which are determined at the sole and absolute discretion of the Conference Organizers. In such case, no refunds will be given.
 - a. Theft, in which case the authorities will be notified;
 - b. Disruptive behavior to other vendors, attendees, ParaNexus staff, hotel staff, or anyone else;
 - c. Threatening statements or behavior, in which case the authorities will be notified;
 - d. Intoxication or under the influence of alcohol or drugs (including prescription medication);
20. All vendor table purchases are non-refundable for any reason except in the unlikely event of cancellation by ParaNexus Organizers, or disasters or acts of nature that prevent the event from occurring and only if another venue cannot be found within a 90 day period. If after registration you determine that you cannot attend, your vendor table may be transferred to another vendor or credited to a future event provided that notice is given prior to the event.
